

# Off Licence

Section 17 to 20, 64 and 135, Sale and Supply of Alcohol Act 2012



**007/OFF/9004/2015**

Section 40 of the Act applies to this licence.

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **St Vincent's Cave Limited** (the licensee) is authorised to sell alcohol from (but not on) the premises situated at **10-18 Customs Street East, Auckland Central, Auckland**, and known as **St Vincent's Cave**, and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

## **CONDITIONS**

This licence is subject to the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day; or at any time after 11pm on any day and before 6am on the next day
- (b) **Alcohol may be sold from the premises by way of remote sale (s.40 endorsement), during the following days and during the following hours: Monday to Sunday 8.00am to 8.00pm; except that alcohol must not be delivered on the following days and hours:  
After 11pm on any day or before 6am the next day; and  
on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.**
- (c) The fees payable for the licensing of the premises concerned are the following risk rating: **low**.
- (d) The licensee is required to ensure that it complies with any age verification measures outlined in the relevant regulations and with information requirements as outlined in s 59.
- (e) The premises is to be undesignated.
- (f) The licensee is exempt from the requirement to have a manager on duty by virtue of s.215(1)(c). However, it must have at least one certified manager appointed to the off-licence at all times.
- (g) Drinking water is to be freely available to customers while alcohol is being supplied free as a sample on the premises and signage directing people to drinking water must be prominently displayed on the premises at that time.

## **DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) Until the close of the period for which it was last renewed; or
- (b) If an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.
